PUBLIC PROGRAMS. MAS HELD A SERIES OF PUBLIC PROGRAMS IN 2015 TO FURTHER ITS MISSION, INCLUDING THE FIFTH ANNUAL MAS SUMMIT FOR NEW YORK CITY. THE EVENT GATHERED MORE THAN 125 SPEAKERS FROM THROUGHOUT THE WORLD OVER TWO DAYS AND FOCUSED ON THE THEMES OF EQUITY, PLACE, AND OPPORTUNITY, ADDRESSING THE NEED TO CREATE AN URBAN ENVIRONMENT THAT SUPPORTS ECONOMIC GROWTH AND OPPORTUNITY WHILE ALSO FOSTERING A SENSE OF PLACE AND COMMUNITY. SIMILARLY, MAS'S "COMMITTEE ON URBAN ENTREPRENEURSHIP" CONVENED INDUSTRY LEADERS THROUGHOUT THE CITY IN AN INDEPENDENT, STAND-ALONE EVENT TO DISCUSS STRATEGIES TO HELP NURTURE A STRONG INDEPENDENT BUSINESS SECTOR.

ADVOCACY AND PRESERVATION. MAS PROMOTES INTELLIGENT URBAN DESIGN ON INITIATIVES RELATING TO ZONING, LANDMARK DESIGNATION, AND LAND USE. IS CENTRAL TO MAS'S CORE MISSION. IN 2015, MAS ADVOCATED TO ADVANCE LIVABILITY AND RESILIENCE ISSUES IN NYC THROUGH A HOST OF PROGRAMS, INCLUDING LAYING THE GROUNDWORK FOR A NEW, 21ST CENTURY PENN STATION AND STATE OF THE ART MADISON SQUARE GARDEN, LEADING TESTIMONY ON CITYWIDE HISTORIC PRESERVATION ISSUES AND TOPICS, PUSHING FOR LEGISLATION THAT SUBJECTS SUPERTALL SKYLINE DEVELOPMENT TO PUBLIC, ENVIRONMENTAL AND DESIGN REVIEWS, AND PRESENTING A SERIES OF AWARDS (INCLUDING THE JANE JACOBS MEDAL, THE MASTERWORKS AWARD, AND THE BRENDAN GILL PRIZE) TO INDIVIDUALS WHO ALSO HELPED FURTHER COMPELLING AND IMPORTANT URBAN WORK.

COMMUNITY ENGAGEMENT. SINCE 2007, MAS HAS LED ITS LIVABLE NEIGHBORHOODS PROGRAM (LNP), WHICH HAS EMPOWERED THOUSANDS OF NEW YORKERS (INCLUDING OVER 700 COMMUNITY LEADERS AND STAKEHOLDERS ACROSS ALL FIVE BOROUGHES) TO LEAD CAMPAIGNS THROUGHOUT THE CITY TO ADDRESS LOCAL LAND USE, ECONOMIC DEVELOPMENT, HOUSING AFFORDABILITY, TRANSPORTATION, AND OTHER URBAN CHALLENGES IMPACTING THEIR NEIGHBORHOODS. IN 2015, MAS JOINED WITH THE NYC DEPARTMENT OF SMALL BUSINESS SERVICES (SBS) AND OTHER LOCAL PARTNER ORGANIZATIONS IN COMMUNITIES ACROSS THE CITY TO FOCUS TRAININGS ON SMALL BUSINESS RETENTION, HOUSING, AND ECONOMIC DEVELOPMENT. THE SESSIONS HELPED BUILD THE CAPACITY OF LOCALS, COMMUNITY-BASED ORGANIZATIONS, AND BUSINESSES, AND LEFT THEM WITH THE MATERIALS TO ADVANCE COMMERCIAL REVITALIZATION STRATEGIES. MAS ALSO DIRECTED RESIDENT-LED DESIGN PROGRAM IN BROWNSVILLE, BROOKLYN. DEVELOPED IN PARTNERSHIP WITH THE CENTER FOR COURT INNOVATION, MAS IMPLEMENTED PROPOSALS CONCEPTUALIZED BY A COHORT OF 20-30 YOUNG PEOPLE AGED 16-24 TO REHABILITATE, ENLIVEN AND TRANSFORM TWO KEY ASSETS (BETSY HEAD PARK AND BELMONT AVE., A COMMERCIAL CORRIDOR) AFTER A YEAR OF TRAINING IN URBAN DESIGN, PLANNING AND CREATIVE PLACEMAKING PRACTICES.
